The minutes of the meeting of June 29, I960 were read by the Secretary and approved as read.

The Executive Director presented the problem of depositing the city funds to be obtained for the Whitney Project in the amount of \$1, 500, 000. After a discussion, it was agreed that the Whitney funds would be deposited in the Rockland Atlas Bank and that the present \$45, 000 Whitney Project balance would be transferred out of the Merchants National and combined with the Rockland Atlas Whitney funds; also, that the City of Boston Government Center planning funds of \$138, 000 presently in the Rockland Atlas be transferred to the National Shawmut Bank and that instructions be given to both banks for the investment of excess funds in Treasury bills.

The Executive Director recommended that the owners of the retained buildings in the New York Streets Project Area be notified that the Authority had changed its plans to amend the project contract and that these buildings would not be taken, so that these owners can make their plans accordingly for renovation and improvements.

The Executive Director was instructed to contact the owners verbally and so advise them.

Mr. McCloskey entered the meeting at this point.

The Executive Director notified the Authority that arrangements should be made to provide public liability insurance for the Whitney area in order that the project area be covered at the time of the taking. On motion duly made and seconded, it was unanimously

VOTED: that James F. Kelley Company, Inc., be designated as broker for the insurance coverage in connection with the Whitney Project.

Site Office reports were distributed.

On motion duly made and seconded, it was unanimously

VOTED: to empower the Executive Director or General Counsel to authorize and approve settlements recommended by Wasserman & Salter, collection agents, on delinquent rent accounts.

On motion duly made and seconded, it was unanimously

VOTED: to adjourn.

The meeting adjourned at 11:45 a.m.
