torn down and not replaced and under existing conditions it is improbable that the buildings will be replaced, and because of a substantial change in business and economic conditions, and because of inadequate light, air, and open space, and because of excessive land coverage, and because diversity of ownership, irregular lot sizes and obsolete street patterns make it improbable that the Park Plaza Project Area or either major subdivision aforesaid thereof will be redeveloped by the ordinary operation of private enterprise; and

2. That the Park Plaza Project Area in its entirety, and each of such major subdivisions thereof, is blighted and decadent.
