SUBJECT: PROPOSED DISBURSEMENT OF CHARLESTOWN MITIGATION

FUND (CENTRAL ARTERY NORTH AREA ("CANA") PARCELS—CITY

SQUARE)

SUMMARY: This Memorandum requests that the Boston Redevelopment Authority

(the "BRA") authorize the disbursement of a total of \$100,000 in varying

amounts to eighteen (18) Charlestown non-profit community

organizations per the request of the Charlestown Neighborhood Council.

The funds will be disbursed from the Charlestown Mitigation Fund maintained by the BRA from contributions made by the developers of the

City Square CANA parcels.

THE CHARLESTOWN MITIGATION FUND (CANA PARCELS—CITY SQUARE)

The Charlestown Mitigation Fund (the "Fund") was established to address social impacts of development projects occurring at CANA parcels located at City Square in Charlestown. The developers of the CANA parcels donated \$925,000 to the Fund. The Fund is maintained and accounted for by the BRA and disbursements from the Fund require approval of the BRA Board.

A process for disbursement of the Fund has been established whereby the Charlestown Neighborhood Council Mitigation Committee conducts an annual public process for non-profits that serve the Charlestown community to apply for funding. The non-profits submit an application and make a presentation regarding their programs and the proposed use of the Fund. The Neighborhood Council then makes recommendations to the BRA requesting disbursements from the Fund.

This \$100,000 will be the eleventh authorization for disbursement from the Fund. An expenditure of \$200,000 to the Charlestown Boys & Girls Club Capital Campaign was approved by the BRA Board on June 13, 2003; an expenditure of \$80,250 was approved

by the BRA Board on January 8, 2004; an expenditure of \$80,249 was approved by the BRA Board on February 3, 2005; an expenditure of \$50,001 was approved by the BRA Board on January 26, 2006, an expenditure of \$53,000 was approved by the BRA Board on February 13, 2007, an expenditure of \$58,000 was approved by the BRA Board on January 31, 2008, an expenditure of \$90,000 was approved by the BRA Board on January 29, 2009, an expenditure of \$107,001 was approved by the BRA Board on December 17, 2009, an expenditure of \$105,000 was approved by the BRA Board on February 11, 2011, and an expenditure of \$104,999 was approved by the BRA Board on January 12, 2012. Including this proposed expenditure, there will be \$1,028,500 in expenditures. Over \$170,000 has accrued in interest on the account and there are sufficient funds to make this disbursement

PROPOSED DISBURSEMENT FOR 2012

On December 4, 2012, at the regularly scheduled monthly meeting, the Charlestown Neighborhood Council voted unanimously to ratify the recommendations of the Mitigation Committee as to the awarding of funds to local non-profit organizations. The Neighborhood Council voted to request that the BRA authorize the expenditure of \$100,000 from the Fund, to be paid as follows:
