SUMMARY: Reporting directly to the Chief Information Officer (CIO), the Boston Redevelopment Authority, (BRA) is searching for a energetic and enthusiastic Web Application Developer with background in building scalable, predictable, high-quality Web applications on Microsoft technology stack.

- Develop web-based solutions and web-enable existing client server and SQL applications in a team-based environment.
- Serve as the first tier of support for identifying bugs, issues and other application anomalies reported from application end users.
- Troubleshoot ASP, SQL, C# and VB solutions to ensure quality, functionality, reliability, and stability.
- Migrate applications using classic ASP to the newer versions of ASP.NET.
- Develop user documentation (as required by individual projects).
- Collaborate with developers, business analysts, and internal customers in the conceptualizing and development of new internet and intranet facing applications.
- Assist in the definition, development, and documentation of business requirements, objectives, deliverables, and specifications on a project-by-project basis in collaboration with internal users and departments.
- Document and execute test plans.
- Train end users to operate new or modified applications.
- Conduct research on emerging application development software products, languages, and standards in support of procurement and development efforts.
- Recommend, schedule, and perform software improvements and upgrades.
- Provide guidance to other team members.
- Perform other related duties as required.

QUALIFICATIONS: Work requires a Bachelors degree plus 4 years of progressively responsible full or part-time experience as an application developer. Must have demonstrated experience delivering enterprise class business applications using web and .NET. Strong knowledge of .NET technologies (VB.NET and C#) is mandatory. Experience with IIS, HTML5, CSS, JavaScript, and Microsoft SQL (TSQL) technologies is needed. Knowledge of classic ASP and VBScript legacy technologies is preferred. Must have experience troubleshooting small to medium sized applications written in legacy technologies (Classic ASP); knowledge of .NET design patterns. Experience with version control software is desirable. Knowledge of XML, XSD, XSLT is preferred as is experience with Web Services. Experience working with Web Content Management Systems is preferred (Kentico a plus). Experience working with GIS mapping APIs is also a plus. Experience with jQuery or similar libraries is strongly preferred. Must have an excellent understanding of coding methods, Software Development Lifecycle, Secure Coding Practices. Thorough understanding of Windows Server and IIS Server is required. Experience interviewing end-users for insight on functionality, interface, problems, and/or usability issues is needed. Must be able to communicate effectively with non-technical staff and with members of interdisciplinary teams; must have hands-on experience developing test cases and test plans. Flexibility and adaptability in learning and understanding new technologies are necessary. Must be highly self-motivated and directed with proven analytical and problem-solving abilities. Experience working both independently and in a team-oriented, collaborative environment is desirable.
