VISION

GREAT STREETS

- Narrow sidewalks on corridor do not meet "Space to Walk" criteria
- Complimentarity—Auto uses in certain segments are not complimentary
- Sidewalks are not "fully public" because abutters have some maintenance responsibility
- Narrow sidewalks restrict ability to make great spaces or add items of interest
- The assessment presented is overly optimistic
- Encourage second floor uses with terraces in front
- Can bump outs be added for trees
- We need to look at the larger issue
 - o 75% of right of way is for cars
 - o 25% for everyone else
- Arborway Committee is running forums on "Visioning Centre Street"

INVENTORY

- Vineet says "Radically rethink the street"
 - o What is a 21st century street?
 - o "Complete" streets'
- Coordinate with ongoing city efforts
 - o Bike sharing
 - o Complete Streets
- "Best Practices" for sustainability
