Dear Raul:

I am writing to you firstly as a resident of Bellflower Street in Boston's Polish Triangle. Secondly, as a member of the McCormack Civic Association and a member of its Executive Board, and lastly as the President of the Polish American Congress of Eastern Massachusetts.

This letter is to affirm my support, as well as the residents of my building on Bellflower Street, the Polish community in the Polish Triangle, and many members of the McCormack Civic Association of the Eden's Development of South Bay.

The City of Boston is in a housing crisis and Mayor Walsh has set an ambitious housing goal for the city to alleviate this crisis. We must all do our part to help in reaching that goal. One way we can do that is to support projects like Eden's South Bay development.

The development will bring jobs and much needed housing to the City of Boston. The development will increase vitality in a desolate area of our neighborhood. The development will also bring more retail and restaurants, which in my opinion, are lacking in Dorchester and particularly the Polish Triangle.

While there are aspects that I don't love about the development (e.g. no office space, increased traffic), I believe the overall plan is sound, and will be beneficial to the neighborhood. The positives of this project far outweigh the negatives. Additionally, the developer, specifically Keith Hague, has been a willing partner in the community process, has agreed to continue to support the community, and has met the majority of the issues we, as a community, have raised.

A project of this size in your (metaphorically speaking) backyard, can at times seem scary or overwhelming, but I believe in the mixed-use, transit oriented development that is proposed, and think we need more projects like this in the City of Boston. As a younger resident of Boston, I experienced firsthand how hard it is to find a nice place to live -- to find affordable housing -- and to save to buy a home. I know that we need housing in Boston, and we need this development.

Further, to have activity in a formerly light industrial area that has been mostly vacant is only positive for the community. I know that I speak on behalf of many others who will be writing, when I say that
