Text Amendment Application No. 491 City of Boston Department of Neighborhood Development Executive Suites

TO THE ZONING COMMISSION OF THE CITY OF BOSTON:

The City of Boston Department of Neighborhood Development hereby petitions the City of Boston Zoning Commission to amend the text of the Boston Zoning Code, as established under Chapter 665 of the Acts of 1956, as amended, as follows:

1. By inserting the following definition into Article 2 of the Code following the definition for " ":

"Executive Suites. Any dwelling (other than a boarding house, dormitory, fraternity, lodging house, sorority house, hotel, motel, or apartment hotel) in which living space, with kitchen facilities, is let to fewer than ten persons who are not related by blood, marriage, adoption or other analogous family union, primarily the temporary abode of persons living elsewhere."

- 2. By amending Article 8 (Regulation of Uses) as follows:
 - a. **In Section 8-7, Table A, Use Regulations**, insert the following use item after Use Item No. 15:
