Historical Boston in Context - Neighborhoods

Historical Boston in Context - Neighborhoods compares the United States, Massachusetts, Boston, and Boston's neighborhoods across several demographic and housing characteristics over the past few decades. These data are a combination of 1970-2000 U.S. Decennial Census data.

Neighborhood boundaries in this report are based on zip code and zoning boundaries. Unfortunately, Census geographies change over time, making approximation necessary when tabulating historical data. We make use of the Longitudinal Tract Database (LTDB)¹ to keep boundaries as consistent as possible.

To do this, we assign each 2010 Census Tract to the neighborhood where the higher concentration of residents lived at the Census Block level. For each year from 1970 to 2010, the LTDB provides weights to allocate the population of Census Tracts in earlier years to 2010 boundaries. These weights use population concentration at the Census Block level to assign population from 2000 to 2010 boundaries, and use land area to develop weights for earlier years.

For instance, if a Census Tract was split into two between the 1970 and 1980 Censuses, and remained unchanged thereafter, the population of that 1970 tract will be divided between the two newer tracts in proportion to the share of the total land area contained in each new tract. For a tract that split between 2000 and 2010, the population will be divided between the newer tracts in proportion to the share that lived in each new tract based on a geographic match of 2000 Census Block level data to the new tract boundaries. The latter method is more accurate, but the geospatial data required for the match was not available for earlier years.

While significant changes do occur in tract boundaries between Censuses, most of these changes occur within neighborhood boundaries, meaning they have no impact on the neighborhood level analyses presented in this report. Therefore, it is unlikely that the data presented here would be particularly sensitive to different methodological approaches to tract matching.

Because they cannot be separately identified at the Census Tract level, the neighborhoods of Chinatown, Leather District, and Downtown are combined into "Downtown" for the analyses here. The same is done with the South End and Bay Village. The consolidated neighborhood is called "South End" for all tract level analyses.

The data presented here can be compared to data from the 2010 Decennial Census and the 2009-2013 American Community Survey by referring to our *Boston in Context – Neighborhoods* report issued in August 2015.

A Note on Race and Ethnicity

For this report we tabulate data for seven race categories derived from the race and ethnicity variables used by the Census. The Census provides separate variables for race and Hispanic ethnicity. We include anyone identifying their ethnicity as Hispanic in the Hispanic category, and omit them from all other racial categories.

For 1970, we know only the total Hispanic population of each area, not the Hispanic population by race. At the neighborhood level we estimate the non-Hispanic population for each race using neighborhood level ratios from the 1980 data. Based on the Hispanic share of members of each racial group in 1980 we form a preliminary estimate of the Hispanic population by race for 1970. These preliminary estimates are then scaled up or down proportionally to match the total size of the Hispanic population (of all races) for each neighborhood as measured in the 1970 Census.

Because this method is not easily adaptable to larger geographies, we do not attempt to subtract Hispanics from the other racial categories at the state or national level. The Census reports the non-Hispanic White population, which we use here, but the numbers for other racial categories include Hispanics. This results in double counting of non-White Hispanics.

The Census only began to allow respondents to identify more than one racial group to which they belonged in the 2000 Census. We include “Two or More Races” as a separate race category for that year, but are not able to estimate a comparable number for earlier years.
