The Executive Director read a letter from Councillor lannella concerning the relocation of West End families in Franklin Hill Avenue Housing Project.

VOTED: that the Site Office Manager, John Hallisey, or James Dazzi, the Assistant Site Office Manager, be and hereby are authorized to approve the relocation payments to eligible firms who were displaced from the New York Streets Project Area, U.R. Mass. 2-1. The Executive Director recommended a proposed change in the By Laws as follows: that Article 3, Section 1 of the By Laws be amended by adding the following sentence: "The Executive Director may sign all requisitions, forms, applications and other transmittals to the Housing & Home Finance Agency and other public agencies in connection with the planning and execution of renewal projects."

On motion duly made and seconded, it was unanimously

VOTED: to discuss the foregoing amendment to the By Laws at the next meeting on July 16, 1958.

On motion duly made and seconded, it was unanimously

VOTED: to attend a meeting with the Members of the Planning Board and staff to discuss future projects after the adjournment of this meeting.

On motion duly made and seconded, it was unanimously

VOTED: to adjourn.
