Boston Harbor Now respectfully submits the following comments on the responses submitted to the Lovejoy Wharf civic and cultural space Request for Information (RFI) by the North End Historical Society, Toussaint Louverture Cultural Center, and Transformative Culture Project. Our staff have reviewed the proposal submission summaries provided on the Boston Planning and Development Agency's (BPDA) website and watched a recording of the public presentation from June 1, 2023.

As longtime stewards of the Boston Harborwalk, Boston Harbor Now is committed to ensuring that the waterfront we build today is designed for a more resilient and inclusive future. We use the term "Harborwalk 2.0" to capture the aspirations of this work to ensure the waterfront is accessible and welcoming; is prepared for the coastal impacts of climate change; and centers equity and inclusion in the development of its design, construction, and programming. An accessible waterfront should have both linear and lateral connections between the city and the water, as well as numerous activation strategies to serve all Bostonians. A resilient waterfront includes a variety of climate adaptation strategies to protect and serve Boston at a district scale. To center equity in waterfront design is to focus on strategies that make the waterfront feel safe and inclusive through lighting, signage (preferably multi-lingual), full ADA accommodations, and the elimination of features that make users feel unwelcome or excluded.

The Lovejoy Wharf RFI presents members of the public with the opportunity to weigh in on a new civic/cultural space on the waterfront. Although the building was completed in 2017, this Facility of Public Accommodation (FPA) has remained vacant rather than providing a promised amenity. We commend the BPDA and City of Boston (COB) for creating a more transparent and community-informed selection process to

We appreciate the thoughtfulness of each proposal and note that all of the applicants have outlined engaging visions with the promise of bringing new activities and audiences to the wharf. As the review committee evaluates the qualified proposals, we hope they will consider the selection of a team that can attract a new audience to the waterfront, create a welcoming environment for all, and successfully implement their vision of this space.

#### Evaluation Criteria

After reviewing the presentations and responses of the qualified applicants, we believe all three have the potential to activate Lovejoy Wharf in unique and compelling ways. We commend the applicants for the creative thinking and passionate enthusiasm that they brought to their visions. As we believe each proposal had merit, we are not writing a letter to endorse a particular selection. Rather, Boston Harbor Now recommends that the selection committee considers the following evaluation criteria and work with the selected group to further these goals. First, the selected proposal should be able to attract new audiences to the waterfront. Along Boston's waterfront, there are many spaces intended to appeal to the general public, but there are many fewer spaces explicitly designed and programmed to bring underrepresented communities to the waterfront, particularly low income and BIPOC residents. As a part of this process, which allows for more influence on the choice of ground floor use, we would like to see a space intentionally designed with equity in mind to attract communities that have not historically felt welcome at the waterfront.

Even if the new space is tailored to a specific group of users, we hope that everyone who visits the area feels welcome in the space through its amenities, programs, signage, and price points. To create a welcoming environment, we expect the selected respondent to clearly outline what amenities they intend to provide to the general public during opening hours and how to access them. If the respondent hopes to provide space for rent, for example, we hope they have clear guidelines on how neighborhood groups and nonprofits can sign up to use the space and what rental discounts they may be eligible for. Similarly, we hope any programs or classes open to the public are well-advertised and affordable ways to participate are made available. If this space is intended to house a public restroom as part of Lovejoy Wharf's Chapter 91 obligations, its availability should be indicated on exterior and interior signage, and it should be located in a place that is accessible even during events. We also hope that any



15 State Street Suite 1100 Boston, MA 02109 617 223 8667 bostonharbornow.org organization selling food or gift shop items or charging for services offers a diversity of price points so that they are accessible to a wide range of patrons.

Finally, we hope the selection committee chooses a team that can implement the ideas that have been outlined in the proposal. While this location has many strengths, including its proximity to a variety of public transit options, activating this space may still be challenging. The room is oddly shaped and may prove complicated to build out. We hope the selected respondent can overcome the unconventional layout of the space and provide consistent, high-quality activation to capitalize on the special location.

#### The RFI Process

We wish to note that the BPDA and the COB have organized an RFI process that is worth replicating. We appreciate that the process allowed for a level of transparency and public input that is rarely executed at this level during typical Article 80 or Chapter 91 processes. We are especially pleased that the RFI process has solicited diverse applicants who all have the potential to bring new and exciting ideas to an FPA space and provided the community with a broader menu of options for imagining what is possible in that space. We hope the success of this process can be replicated for other FPA spaces in the future. Should this process be repeated, we recommend that the BPDA and COB provide feedback to unsuccessful applicants that will enable them to more effectively apply for and be considered for FPA spaces that may be available elsewhere on the waterfront.

We are grateful for the opportunity to comment on this project and look forward to following its progress toward implementation. We would be happy to speak with you or the selected proponent further if there are additional questions.


Dear Mr. Delaney -- Just back from the "Old Country" in time to meet the deadline -- I'm an old reporter -- for comments on the proposed Italian-American Museum at Lovejoy Wharf. Here's a slightly personal reason for a museum: A home for my files from the early 1950s: some of my many stories and editorials in The Italian News, a North End weekly owned and published by city councilman, attorney, businessman Gabriel Piemente. As far as I know, entire issues of the paper were never saved by the Boston Public Library.

My files provide a picture of a newspaper reporting about a community active in local and national Italian-American activities and interests. We ran long interviews with prominent Italian-Americans, under the column head "Genus Ausonia". I recall interviewing singers, actors, scientists, professors, business people, public officials -- I am suprised to think back at how many famous people were happy to devote time to a reporter from a small weekly Italian-American newspaper. How they told of their hertitage, their families, their pride in their Italian descent.

Our editorials campaigned hard against bigotry, stereotyopes of Italians, local developments (we helped save Chinatown from destruction for a highway ---- minority interests were interests of all), Italian national activities (the Trieste question), yes, and the everlasting North End issue: parking. A major campaign was to eliminate the racist, bigoted immigration quota laws of our country.

One story were were especially delighted with was published the morning before Tony DeMarco won the world championship: Our story accurately reported that Tony won the fight. A graph at the end discosed that no matter how the fight really ended, Tony would always be the North End's champ.

I could go on and on about the feistry, determined, tireless, Italian News, A North End Museum would be the finest home for my files. telling in print the stories and views of Italian-Americans of the early 1950s.

#### Dear Delaney,

I am writing to support Tommy Damigella's proposal for the North End Museum and Waterfront Center run by the North End Historical Society (NEHS.). I view the ongoing story of the North End from 1630 as the story of America and its people, not just the story of one neighborhood. It is why I recently joined the NEHS as a voluntary Board Member.

I am of Italian American descent who grew up in the North End for over 25 years with a family of immigrants that owned the D'Alessandro Religious Goods Store (aka, the "Saints Store") and served the North End Community for 72 years. I have remained active in North End institutions and activities since I was a boy.

I was fortunate enough to go to the Eliot School (the oldest public elementary school in New England – 300 years) and Boston Latin School as well as Tufts University and Harvard for undergraduate and graduate degrees. Remembering the air and water pollution - especially of Boston Harbor, I served in the EPA beginning in 1970 when it was created, and then as Commissioner of the Department of Environmental Protection under Governors' Ed King and Michael Dukakis. While I was Commissioner, the state enacted the toughest hazardous waste prevention and clean up legislation and regulations in the country. We oversaw \$500 million in Federal and state grants for municipal water pollution control including Boston Harbor. We were far from done. We were strong advocates for the later creation of the Massachusetts Water Resources Authority and for the expansion of the Chapter 91 authority for public access and protection of the coastal tidelands - a huge benefit for the North End and all of Boston Harbor.

I wanted to work on ways for all people to have access to clean air and water, safe beaches, and harbors. I was dismayed that the education I got in the Eliot School, Boston Latin, and early college years did not provide the deep history of the North End and Boston, as the country's oldest city. I was also disappointed by the superficial educational treatment of the critical relationship of our environment to our health, and economic opportunity. That led to a career in helping hundreds of higher education institutions transform education, business operations and investments to create a more just and sustainable society.

With the museum, we envision informing North Enders, former North Enders and visitors and others about the richness of the continuing culture of the North End. We imagine new and better connections with important cultural icons in Boston, e.g., the Athenaeum, the Boston Public Library, historical societies, a variety of colleges and universities and the Boston Public School System. And we envision working closely with the City of Boston, the MWRA and various non-profit groups on protecting Boston Harbor and addressing the existential challenge of climate disruption.

In addition, NEHS is leading a collaborative effort with St. Leonard Church and other leaders to establish a public art project in the St. Leonard Church Peace Garden. It will commemorate the immigration of English, Jewish, Eastern European, Irish, and Italian immigrants since 1630. It is to be called "The Noble Journey Sculpture." St. Leonard Church was the first Italian church in New England built by Italian Immigrants in

1873. We are thrilled to have engaged Nancy Schon, famed sculptor of the "Make Way for Ducklings" in the Public Garden. https://schon.com/public/ as our designer.

The North End Museum presents an opportunity of a lifetime to expand and connect the rich history of Boston, truly the "Cradle of Liberty." I am honored to work with Tom Damigella, a visionary, passionate, and experienced businessman and North End leader, and the talented, committed group of people he has brought together.



To the Boston Planning and Development Board:

I was unable to attend the presentation by the North End Historical Society, but I was able to watch the recorded Zoom version, which I downloaded. I'm wholly in favor of the proposal and believe it will inform and educate Bostonians and visitors about this patch of land and it's contributions to the ongoing history of our nation. I believe that such a museum would have important things to say about how different immigrant societies, some more established than others, have learned how to live and get along with each other.

Yes, I favor the North End Historical Society proposal partly because my grandparents and my parents on both sides of my family began their lives there -- call that sentimental nostalgia, if you wish. But more important, as a university professor, I taught courses and directed dissertations in American history and literature, and I know the connections between the historical past and the terrible disputes that threaten our nation today.

The North End saw the early English settlers gradually displaced by other Europeans and those others later displaced by masses of Irish immigrants, then Jews in smaller numbers, and Italians in very great numbers. And these immigrants didn't arrive at an empty North End, they found it populated by the group that had arrived earlier. As the North End changed from a largely Yankee population to an Irish population, or from Irish and Jewish population to Italian, they lived together. At different times throughout its history, the North End has been a mixed neighborhood -- or as people say today, a diverse neighborhood, an inclusive neighborhood. It hasn't been easy, but by and large the North End has seen the mingling of different peoples as a peaceful drama.

A museum displaying the long, fascinating story of Boston's North End would be a powerful way to teach people that our ideals of diversity and inclusion are reachable goals -- that this nation of immigrants can learn how to take pride in our origins and how to celebrate not only our own ethnic past but our neighbor's as well. We can get along. It would be helpful if every generation learned that. I believe this is a great proposal and one that will truly help the city and state and, indeed, people everywhere.

This letter is being sent to show my support of Tom Damigella's proposal for the creation of the North End Museum and Waterfront Center. I have a strong connection to the area because my four grandparents, who emigrated from Italy between 1905 and 1910, settled in the North End. I grew up in my maternal grandparents' building located on North Bennett Street directly across from the North Bennett Street Industrial School and a block from the Old North Church. In fact from our roof top deck we could see the church's spire which made us very aware of the community's colonial history.

Our building was home to not only my parents and me but also my grandparents, three aunts, two uncles, and five cousins. I have memories of visiting extended family who lived in the neighborhood and of shopping daily at bakeries, butcher shops, fruit and vegetable stores, and for fish sold from push carts. My grandmother owned a store front business of her own, D'Alessandro's Religious Goods. It was lovingly referred to as The Saints Store because of the display of saint statues in the window. Besides religious merchandise she also sold greeting cards, school supplies, small toys, and candy. Many children stopped on their way home from school to buy an afternoon snack. I am proud that the store was an integral part of the neighborhood.

The North End has played a major role in the history of the City of Boston, being the first area settled by the Puritans. Its proximity to the harbor and the Charles River and its being a bit isolated from the mainland part of the city made it a safe, perfect location for settlement. When the neighborhood began to get more and more crowded, the descendants of the original English settlers moved to other sections of Boston. The North End then became home to new immigrant groups; the Irish, Eastern Europeans, the Italians. Because of the North End's connection to our nation's immigration narrative, its importance should be recognized. The museum would provide stories of this very unique community and its contributions to the history of Boston and the nation.

Dear Delaney Morris:

I am writing to support the application of the Toussaint Louverture Cultural Center (TLCC) for a cultural space at LoveJoy Wharf. Haitian culture is fascinating and underrepresented in Boston, Massachusetts has deep and interesting historical ties to Haiti, and the area is a major hub for Haitians and non-Haitians engaging in Haiti. I have attended dozens of events organized by Haitian Americans United and other TLCC leaders, and have invariably found them well-run, compelling and well-attended.

I am a third generation Boston native. My ancestors came here from Ireland, because of many of the same economic, political and family reasons that have induced Haitians to come to Boston over the past half century. My ancestors experienced many of the same hardships, discrimination and successes that Haitians are experiencing as their community establishes its place in Boston. These connections between the Haitian and Irish experiences inspired me to go to Haiti in 1995 as part of a UN human rights mission working to re-stablish democracy in Haiti.

I stayed in Haiti for nine years, and the whole time I kept running into other people from Massachusetts: Haitian Americans serving as police trainers and leading economic development projects. Paul Farmer and his colleagues from Partners in Health, leaders of other Massachusetts-based non-profits such as the Matenwa Community Learning Center, delegations from Catholic parishes hosted by the Saint Boniface Haiti Foundation (now Health Equity International), students from Massachusetts colleges and universities studying law, healthcare, anthropology and much else, members of Congress and many more.

When I left Haiti to start the Institute for Justice & Democracy in Haiti (IJDH) where I am Executive Director, we chose to locate the organization in Boston because of the vibrant and engaged Haitian community, the deep engagement of local non-Haitians with Haiti, and the colleges and universities interested in Haiti. All of those groups have significantly enhanced IJDH's work. We collaborate regularly with Haitian-Americans United and other organizations on improving U.S. policy to Haiti and to Haitians in the United States. We have the privilege of inviting local Haitian-American experts to speak to our organization and at events we help organize in Massachusetts and elsewhere. We receive significant collaboration, insight and inspiration from other local non-profits, and funding from local philanthropists. We hire staff and recruit interns from local institutions of higher learning, partner with them on advocacy work, and regularly speak at their events on Haiti.

IJDH's work to improve U.S. policy to Haiti has also benefitted from the substantial increase in the Massachusetts Haitian community's political power over the past two decades. Pioneers of the Haitian-American Community, such as Marie St. Fleur, the first Haitian-American State Representative in the U.S., and Linda Forry, the first State Senator, have been joined by a new generation in municipal government across Eastern Massachusetts, including Boston City Councilor at Large Ruthzee Louijeune. Non-Haitian elected officials from Massachusetts are leaders in addressing U.S. policy to Haiti, including Representatives Ayanna Pressley, a founding member of the House Haiti Caucus, Catherine Clark and Jim McGovern, and Senators Elizabeth Warren and Ed Markey, a leading voice on Haiti in the Senate.

Perhaps the most exciting part of IJDH's presence in Massachusetts is the opportunity to participate in cultural events organized by the Haitian-American community. Our staff, our friends and families love the art shows at City Hall, universities and private galleries, that are an opportunity to both experience wonderful art and connect with old and new friends. We learn about the interconnected histories of Haiti and Massachusetts at events such as this month's "What Would Frederick Douglass Say" event at Old South Meeting House. We enjoy dance and music by youth and adults at H.A.U. annual events, including the Independence Day Gala in January and Haitian History Month in June.

Granting the TLCC a cultural space at LoveJoy Wharf is an exciting opportunity to bring the contributions of Haitian culture and history to Massachusetts to a whole new level. A permanent cultural center would facilitate more programming, and it would help reach a whole new audience who will, like me, become enchanted and inspired by Haitians in Haiti and in Massachusetts. The IJDH team—and our friends and family—look forward to participating in TLCC events, and to help organize events within our area of expertise.

I have attended dozens of events organized by TLCC leadership, and every one has been well organized, well attended, and run with an uncommon graciousness. A City Hall art exhibit two years ago is illustrative. Like many people, I arrived at the crowded event just when the formal program was beginning, so did not have the chance to view the paintings and catch up with friends beforehand. City Hall was closing for the day soon after the program ended, but no one wanted to leave—there was just two much good art and good conversation to be had A battle that was as pitched as it was polite ensued, with the organizers trying mightily to guide people out of the event they had made too compelling and the attendees trying to grab one last look at a painting or minute of conversation. The organizers succeeded in getting us out to City Hall Plaza, but the conversations--about art, politics, history, friends and family, in Haitian Creole, French and English--continued long after the door to City Hall closed.

My paternal grandfather come to this country in 1881 from Chiusano di San Domenico, Avellino, Campania, Italy. He worked as a laborer and In 1891 was able to send for my grandmother and my three uncles. In 1893 with help of his sons, the he purchased a newly constructed tenement house on Fleet Street, the street where I would be born many years later.

My mother came to this country in 1917 from Airola, Benevento Campania, Italy. Her immigration story differed greatly from the Fucillo's. Her father had died in Italy and she was born into poverty and upon arrival to Boston her tiny family comprised of my grandmother and my aunt relied on "Relief' to survive.

Both of these stories need to be told and remembered. My family's story is mixed with joy and sorrow, but never has my pride of being a North Ender ever diminished. However there is a grave problem! With each passing day another person leaves us and treasured family stories of the North End are lost. The history of immigrant people is lost! Not only is this a tragedy for the families that lose their heritage, it is a loss to all who should know the History of Immigrants that came to America. Because as another contributor said, when we learn our past we also learn not to make the mistakes that were made in the past. ... Paraphrasing "Those who cannot remember the past are condemned to repeat it." – George Santayana, The Life of Reason, 1905.

I pass my family's story on to the rest of my family. I am the Fucillo/Fuccillo Family Museum. I want this for all North Enders. This Museum can provide a repository for families to take pride in and learn about their past history and search for their ancestors, I see it as a living Ancestry.com. Furthermore, the rich historical legacy of the North End from the 1600's onward would also be presented through various media for all to view. Visitors will be able absorb the uniqueness that makes the North End so invaluable and intrinsic to Boston's history,

The amount of history that Bostonians know about their own city decreases every day. As an educator, I know this first hand. This Museum would be instrumental in preserving and inspiring children as well as adult visitors to be proud of their city and its place in history, Boston is highlighted as the Cradle of Liberty but it must be remembered that many seeds for this Liberty were germinated and brought to fruition in the North End.

As the North End has both Historical and Societal treasures, these immeasurable treasures must be viewed, appreciated and preserved. The direct avenue to reach this worthy goal is the creation of the North End Museum. We cannot bury the past. We must illuminate it.
