





## **Transformative Infrastructure Project**




The Allston Multimodal Project will deliver robust multimodal transit.




## **Project Timeline**



## **Key Hubs**

- Our site is in close proximity to prestigious universities and the thriving Allston neighborhood.
- To the west of our site, a multitude of new development clusters has steadily emerged over the past decade.
- Our site occupies a central position amidst diverse development clusters and neighborhoods, offering exceptional potential to become a dynamic focal point for the community.






## Green Network

- The site has direct access to the Charles Riverfront, ideal for biking and pedestrian activities.
- Nearby, numerous bike-friendly streets enhance accessibility.
- Both the site and Allston face public open space shortages due to density and size limitations.
- The site holds great potential as a new gathering center for the neighborhood with expanded public open spaces.






## **Water System**

- The Charles River Dam protects this area from coastal and ocean conditions, but the impacts of future projected sea level rise and stormrelated events need to be evaluated.
- Water transit access from Downtown to our site could be considered.
- Water sports and recreational activities could serve as additional attractive features for the site.
- The City Tunnel Extension runs north of the site, with a maintenance shaft in close proximity.






## Rail Transit Network

- **West Station** on Worcester Line will be the **major transit hub** for the site, with multiple connecting bus routes.
- Green Line B has multiple stops within 5 minutes walking distance from site.
- The proposed Grand Junction
   Line could be alternative rail
   transit option to Cambridge and
   North Station.






## Bus Transit Network

- Currently bus #64, 66 serves the site; #57 and 60 near the site; #501, 504 and 505 passing through the site without stops.
- Multiple shuttle routes pass through the site, provided by universities and healthcare partners.
- Three new shuttles are proposed to connect West Station with Harvard Yard, Kendall Square and Ruggles Station.






## Road Network

- The site offers excellent car accessibility, with I-90 passing through and well-placed exits.
- **Soldiers Field Road** (Storrow Drive) serves as another vital access route.
- The site is heavily influenced by highways with viaducts and ramps, presenting challenges for pedestrian access.
- There is a notable deficiency in local connections, particularly in the north-south direction through our site.






## Future Projects

- Extensive developments would take place on ERC and Harvard Campus immediately north of the site.
- Boston University has multiple potential development sites south of the site.
- Allston Yards, Western Ave Corridor and Boston Landing west of the site would be another mixed -use development cluster.
- Several **transportation projects** near the site would better connect the site to the rest of the city.





## **Coalition Partner Roles & Responsibilities**

The coalition partners are invited to help the project team **refine the project mission and ensure that the broad range of project outcomes support that mission**. Involvement is anticipated to aid in building coalition partner relationships and advocacy for a plan that enables the long-term vision for Beacon Park Yard. Coalition partners are not an Advisory Group in that they are not tasked with refining or selecting alternatives nor is their participation requested as Technical Subject Matter Experts. These roles will be fulfilled through other engagement work streams.

Coalition Partners are asked to **represent broad regional interests** in planning and design with a preference for diverse representation, a long-term bias, and capacity to speak openly and with authority on the vision for their agency, institution, or peers. Additionally, all topics will be vetted by the project team and through other engagement work streams as described below. The coalition partners will effectively **shape the equity-based overarching project framework** for the BPY Plan.

## **Coalition Partner Workshops Outcomes**

- Project mission workshop (regional equity focus), Planning Preparation, October 2023
   Outcome: a project mission and strategies to guide tasks and outreach
- Site Context and Analysis workshop (study area focus, past), Site Context and Analysis, November 2023
  - Outcome: a social climate analysis, the key cultural and advocacy features influencing future development
- 3. Regional framework vision (study area focus, future), Frameworks, February 2024 Outcomes: strategies for transportation, land use, and heterogeneous cultural design. (secondary: infrastructure, density, urban character, and phasing priorities) Survey: vetting of final frameworks developed through broad and group engagements to confirm alignment
- 4. **Strengthen partnership and identify priority topics, constraints, and opportunities** (plan area focus, future), Scenarios, June 2024
  - Outcomes: priority scenario topics for the project team to explore in broad and focus group engagement
  - Survey: review final scenarios and draft focus area(s) for alignment with priority topics and project mission







#### Goals

#### **Preliminary Theory of Change**

Large-scale planning processes have often resulted in plans enabling development that deepens inequities and compounds existing structural harms, specifically segregation by wealth, race, and status. We seek to establish a plan for future development that directly benefits the local community of immigrants, small business owners, artists, ethnic and racial minorities, LGBTQIA+ people, people with disabilities, those who are house-insecure or food-insecure, and people with limited access to transportation. This will ensure a culturally and economically diverse mix of people connected by development rather than divided by it. We will achieve this by first documenting community and indigenous knowledge of the place and then by using this grounding to facilitate a transparent process that prioritizes power sharing in the creation of universal goals and targeted outreach. Through this process, we will establish guidelines which hold those with power accountable to the current and future community.

#### **Coalition Partner Introductions**

#### What actions will we take to advance equity?

A Theory of Action (ToA) outlines the steps we'll take to achieve the vision in our Theory of Change.

#### Our ToA will guide internal actions to make:

- the City and BPDA more equitable;
- project programming decisions (to achieve positive and equitable results); and
- actions and advocacy (to align public policies and attitudes with equity goals).

A ToA can grow along with capacity (for example, as we take on action items from the Plan, if the AMP receives additional funding).

#### Tips:

The precise content of our initial ToA does not matter as much as ensuring that it is grounded in our ToC. This will require conversations with diverse stakeholders (coalition partners will elevate various perspectives and priorities from the key themes)

ToA is not a work plan;

Consider who should be responsible for these actions, a time frame, and what results will be achieved.
