Too many left out of process, agency says

The city's review process for new developments has long been a tug-of-war among stakeholders, often pitting the surrounding community against petitioners for zoning exemptions. But a new survey by the Boston Planning and Development Agency (BPDA) shows both camps united in dissatisfaction with the current process, as well as a mismatch between the residents most typically engaged and the city's general population.

In two portions of the survey, the BPDA asked community participants and developers about experience with the city's review process for projects subject to Article 80 review. Another portion, aimed at people not yet involved, sought input about community barriers to participation.




